• The Hub


The Access to Justice Knowledge Hub for Fair Participation is about having the voices of persons with disabilities heard equally and fairly within justice system procedures. Having one's voice equally heard is achieved by ensuring effective participation. Accommodations enable this.

The Hub draws from the spirit and letter of the Convention on the Rights of Persons with Disabilities, in particular Article 13 on Access to justice. It also draws from Article 2 (Reasonable accommodations), Article 5 (Equality and non-discrimination), Article 12 (Equal recognition before the law), Article 14 (Liberty and security of the person), and Article 16 (Freedom from exploitation and abuse).
